Application Form

What is the Bursary Fund?

The 16 to 19 Bursary Fund is a scheme to help young people facing financial hardship to stay in full-time education.

The scheme is made up of two parts:

- Those most in need will be eligible for a bursary of up to £1,200 a year. This includes young people in care, care leavers, young people receiving Income Support or Universal Credit. It also includes young people receiving either Disability Living Allowance or Personal Independence Payments in their own right as well as Employment and Support Allowance or UC in their own right.

This bursary is referred to as the “*bursary for defined vulnerable groups*”.

- Other students who need financial support to help them with essential costs to stay in education or training may also be able to claim a bursary to help with costs for essential books or equipment, travel costs for journeys during College time not covered by school transport or a Disabled Person’s Bus Pass or other essential course-related costs.

This bursary is referred to as the “*discretionary bursary*”.

Eligibility

For the bursary for defined vulnerable groups you must meet one of the following four criteria by being a:

- In care (the 16 to 19 Bursary Fund defines ‘in care’ as children looked after by a local authority on a voluntary basis (section 20 of the Children Act 1989) or under a care order (section 31 of the Children Act 1989). Those who are privately fostered are not classed as looked after;
- Care leaver
- Young person receiving Income Support or Universal Credit in their own right*
- Young person receiving Disability Living Allowance or Personal Independence Payments in their own right as well as Employment and Support Allowance or Universal Credit in their own right.*

For the discretionary bursary you must be a student whose parents or carers are in receipt of one of the following:

- Income support*
- Income based Jobseeker’s Allowance
- Support from the National Asylum Support Service
- Tax Credits (Working Tax Credit/Child Tax Credit)
- Guarantee element of State Pension Credit
- Income related Employment and Support Allowance*
- In receipt of Universal Credit

AND expect to have a household Inland Revenue assessed annual income of less than £16,190 for the current tax year (2021/22) and confirmed annual income of less than £16,190 previous tax year (2020/21)

Or be a student who:-

- Is in receipt of Free School Meals or
- Is providing care to a sick or disabled relative or
- Has a long-term medical condition that can affect their studies.

*From 2013 the phased introduction of the Universal Credit to replace Income Support and Employment and Support Allowance and Personal Independence Payments to replace the Disability Living Allowance commenced. Where applicable, these benefits will be taken into consideration.

There are additional criteria that need to be met to be eligible for either bursary. These criteria include course types, residency and age restrictions. We will contact you as part of the assessment process if we believe there will be an issue with meeting these criteria.

Applying

The 16 to 19 Bursary Fund provides financial support to help students overcome specific financial barriers to participation so they can remain in education. Students will only be awarded the amount of actual support they need to enable them to continue their studies at Ivel Valley College.

If you believe you are eligible for a bursary please complete Section A (if you wish to apply for the bursary for vulnerable groups) or Section B (if you wish to apply for the discretionary bursary). You can only apply for one bursary, not both. You will need to apply for a bursary each year even if your circumstances do not change.

Equally, if your circumstances change during the year, which may affect your ability to stay in education and you believe you would benefit from a bursary please speak to the Assistant Principal, Roger Williams about making an application.

Please complete the application in full and enclose supporting evidence as required. We will write to you to confirm if your application has been successful. If agreed we will inform you of how the bursary will be paid and the terms on which it is available. The amount paid to each pupil may also depend on the number of successful applications received.

Conditions and Payment

For either bursary, money will only be paid to help students with the essential costs of participating in a programme of study at Ivel Valley College where financial barriers to participation need to be overcome. Receipt of either bursary is conditional on students meeting agreed standards set by the college and an assessment that the bursary will support students to make at least expected levels of progress. In addition attendance must be 90% or higher and students must abide by the Ivel Valley College Code of Conduct. Payments may be delayed or withheld if you fail to meet the agreed standards. The terms and conditions on which the payments are made will be set out in the confirmation letter.

For the bursary fund for vulnerable groups successful applicants will be advised when their payments for the academic year 2021/22 will be paid. Payments will normally commence just before the October half term break and will be paid on a monthly basis thereafter.

For the discretionary bursary support will be given towards items which are deemed to be essential. The amount of funding for the bursary scheme is limited and the amount paid out will be dependent on the number of successful applications received. Payments will usually be made in kind i.e. items purchased by Ivel Valley College and made available to the student on terms set out in the confirmation letter.

Appeals Procedure

If a student or their parents/ carers wish to appeal the outcome of their application for a bursary, they must follow the school's normal complaints procedure. The final decision will be made by a nominated person outside of the bursary decision making process.

Deadlines

During the relaunch of the bursary scheme for the academic year 2021-22 this form must be completed and returned by 25th March 2022 for funding for the summer term.

The scheme will be available for applications again in September 2022 for the academic year 2022 - 2023.

Data Protection Act 2018:

The information given on the Bursary Application form, together with any supporting documentation will be used by the school for the purposes of processing an application. Information will be kept secure and only shared with staff or organisations for the purposes of assessing, administering and reporting on the bursary scheme.
